#### The City of Malmö's organisation has netzero emissions

The City of Malmö should be a role model and needs to work with the organisation's own emissions in an effective manner. To achieve at least net-zero emissions of greenhouse gases, the City of Malmö's organisation must minimise emissions from direct and indirect sources to the greatest extent possible. The remaining emissions must be compensated with carbon sequestration to achieve netzero emissions. Carbon sequestration should be performed locally to the greatest extent possible.

#### Increased resource efficiency

Increased consumption is causing the Earth's resources to be consumed at an ever-increasing rate, and Malmö's ecological footprint needs to be reduced. Malmö must undergo a transition to a more circular economy where spillage and waste is minimised and energy efficiency is facilitated. Products, materials and resources must be fully utilised, re-used where possible and finally recycled.

#### Indicators

Procurements of circular or eco-labelled food items, products and services. Waste and recycling (for the whole of Malmö)\*.

# Lessons Learnt/Result from pilot



- + Collaboration with suppliers
- + Priority list (internal resource efficiency)
- + 10% reused furniture in 2019 and 15% in 2020
- + 170 000 co2 saved for each year
- + Positive example to lead the way to broader implementation

- + Start with something easy likely to become a success!
- + Policy or practice first?
- + Find engaged allies
- + Behavioral change
- + Be part of networks and look for external money
- + Monitoring difficult but valuable (don't look for the perfect monitoring)
- + Statistics
- + Good examples
